NOTES:

According to the provision of the Rules for the classification of ships of CRS:

- hull items could be surveyed under renewal survey, or, for non-ESP ships and ships other than general cargo ships only, under continuous survey scheme (CSH);
- machinery items could be surveyed under renewal, continuous survey or planned maintenance scheme (CSM);
- refrigerated plant could be surveyed under renewal survey or continuous survey scheme (CSR).

Continuous survey scheme (CS) may be initiated at the time of class renewal survey only.

Ships covered by CS scheme are not exempted from Annual or Intermediate surveys.

When applying continuous survey scheme one cycle of CS should be completed within five years period.

Already commenced CS scheme may be withdrawn by CRS if particular items being due or overdue at the time of Annual or Intermediate survey have not been dealt-up with or postponed by agreement, or upon written request by the Owner.

Withdrawal of already commenced CS scheme has as a result the necessity to carry out surveys according to renewal survey scheme.

If the ship, for which CS scheme is requested to be applied, is dually classed with some other class society CRS shall take all necessary measures to adjust its CS scheme items and pertinent due dates with CS scheme of that other class society.
